Universidad Torcuato Di Tella (UTDT) is a private non-profit institution founded in 1991 by the Di Tella Foundation and the Instituto Torcuato Di Tella, with support from the international philanthropic community. The mission of the University is to educate new generations of academic, social, political and business leaders, and to enhance research and scholarship in the arts and sciences.

The University is organized in schools, centers, and departments, with graduate and undergraduate programs in humanities and social sciences. There are nine academic units: Architecture, Business Economics, Economics, Education, Government, History, Law, Mathematics and Statistics and Political Science and Government. The University offers undergraduate degrees in Economics, Business Economics, History, International Relations, Political Science and Law. It also offers MA degrees in Business Administration, Economics, Education Administration, Finance, History, Law and Economics, Non-profit Organizations Public Policy, and Urban Economics. Two Ph.D degrees have recently been added in Economy and History. UTDT offers weekly workshops in economics, political science, business economics, international affairs, contemporary architecture, writing and literary criticism, and in legal philosophy.

UTDT is a highly regarded Research University in Latin America and its library, founded in 1958, is the most valuable library devoted to the social sciences in Argentina.

Enrollment in 2001 is 1100 undergraduate and 500 graduate students. The faculty consists of 63 full time professors (3 with endowed chairs) and 25 visiting professors. The student faculty ratio is 17,5 to 1. Many faculty members have joint appointments with American Universities, including Chicago, Columbia, Maryland, Rochester, and NYU.

At UTDT the graduate and undergraduate students can complement their academic studies with work experience through the Professional Development program. They are also assisted by UTDT's Young Professionals Program in obtaining employment upon graduation. Toward this end the University maintains strong ties with more than 400 institutions including banks, businesses and governmental and non-governmental organizations, both national and international.
